2 The objects of the Association : The architects of the Association believe that the humanity is one and consider its service as the most important objective of this Association. **Rules & Regulations of JSS MVP**  
(as amended on 13.01.2014)

- I. NAME : "JAGADGURU SRI SHIVARATHREESHWARA MAHAVIDYAPEETHA", MYSORE.
- II. DEFINITIONS : 1. "JSS MVP" means "JAGADGURU SRI SHIVARATHREESHWARA MAHAVIDYA PEETHA".
2. "COMMITTEE" means the MANAGING COMMITTEE OF THE JSS MVP".
3. "JAGADGURUJI" means the Pontiff of Jagadguru-Sri Veerasimhasana Maha Samsthana Math, Suttur, Nanjangud Taluk, Mysore District.
4. "ACT" means Karnataka SOCIETIES REGISTRATION ACT OF 1960.
5. "REGISTRAR" means the Registrar of Societies in Karnataka.
- III. REGISTERED OFFICE ADDRESS : Jagadguru Sri Shivarathreeshwara Mahavidyapeetha, Jagadguru Dr. Sri Shivarathri Rajendra Circle, Mysore-570004.
- IV. OBJECTS : The JSS MVP may take up **charitable activities** and such other activities as it considers necessary in order to achieve the objects specified in the Memorandum of Association. Specifically, the JSS MVP may:
- (a) Establish, institute, acquire, takeover, maintain, run, administer and support institutions for imparting Education viz. Pre-Primary, Primary, Schools for differently abled children, Secondary Schools and Colleges in Arts, Science, Commerce, Social Sciences, Education, Literature including Indian Classics and Physical and Biological Sciences, Engineering, Medical, Pharmacy, Nursing and other Institutions to develop Culture, Literature and Art, etc,



(b) Establish, institute, acquire, take over, maintain, run; administer and support Polytechnics, Schools and Colleges in Agriculture, Medicine, Pharmacy, Nursing, Physiotherapy, Engineering, Management studies and such other Technical and Professional fields as it considers necessary.

(c) Establish, institute, acquire, takeover, maintain, run, administer and support Research Centres for Doctoral and Post- Doctoral Research in Humanities, Science, Management Science, Medicine, Health, Rural Development, Disaster Management of Natural Calamities, Bio-technology, Nano-technology, Aero-Space Engineering, Entrepreneur Development Service, Nutrition & Phyto-sanitary Sciences and Technology including Cutting-edge Technologies.

(d) Promote Mass Education and Adult Education by or through formal or non-formal education by conducting formal or non-formal classes, symposia or by any other mode.

(e) By any other mode establish, institute, acquire, maintain, run, support colleges or conduct through its present & future institutions; vocational courses, job oriented courses, skill training and the like, training centers in general & particularly for differently abled pupils.

(f) Establish, acquire, institute, run, maintain, support reading rooms, libraries, centers for publication of books and other education material; public museums and galleries of works of Art, Collections of Natural History, Scientific Equipment etc,

(g) Construct, take on lease, mortgage, hire, or by any other legal means acquire any immovable properties.

(h) establish, run and administer boarding homes with lodging facilities to students and others as charitable activities, namely;

(i) general free hostels,

(ii) anathalayas / destitute homes / orphanages,

(iii) hostels for differently abled,

(iv) hostels attached to particular Educational Institutions,



- (v) Working Women hostels,
- (vi) Vriddhashrams,
- (vii) Akshara Dasoha Schemes and
- (viii) other, similar institutions.

(i) extend / provide support to sister Institutions of JSS MVP

V. CORPUS

: Corpus of JSS MVP shall include.

(a) Grants, contributions & donations received in cash or in kind from individuals, firms, corporations, charitable institutions and others.

(b) Loans & Grants taken / received from the State & Central Governments & Local Bodies, banks and other institutions or individuals.

(c) Fees, fines & contributions collected from the past & present students of the institutions / Establishments Managed by the JSS MVP.

(d) Income from any other sources

(e) Income derived from immovable and movable properties of the JSS MVP.

(f) All the income remaining unspent or accumulated from year to year or over the years.

(g) Income derived from Consultancy, Training, Testing, Service rendered to any person by any of the Institutions or Colleges of the JSS MVP.

VI. AREA OF OPERATION

: The area of operation of the 'JSS-MVP' may extend to the whole of India and such other countries as may be necessary.

VII. MANAGING COMMITTEE

: (a) There shall be a Managing Committee to manage the affairs of the JSS MVP.

(b) The Managing Committee shall consist of not more than 15 members including the President and not more than 8 Life Members, and such number of Associate Members, as specified hereinafter.



(c) (i) The pontiff of Jagadguru Sri Veerasimhasana Maha Samsthana Math, Suttur, shall be the President of the JSS MVP permanently. The Managing Committee shall have no power to remove the President from the Membership of the Managing Committee and also from the office of the President.

(ii) There shall be an Honorary Secretary of the JSS MVP.

(iii) There shall be an Executive Secretary of the JSS MVP.

(iv) The persons mentioned in the Appendix to the Memorandum of Association shall be the Life Members of the JSS MVP.

(d) No member shall be eligible to be a Life Member unless he

(i) has attained the age of 25 years,

(ii) is / has been associated directly or indirectly with the JSS MVP or the Jagadguru Sri Veerasimhasana Mahasamsthana Math, Suttur, or any Organization connected with the same and is so certified by the President,

(iii) has not been declared an insolvent,

(iv) has not been convicted of any offence involving moral turpitude, and

(v) is free from any bodily or mental infirmity which may prevent him from discharging his functions as a member.

(e) Any vacancy arising among the life members of the Committee shall be filled up by a unanimous decision of the Members of the Managing Committee present at a meeting of the Managing Committee. In case no unanimity is reached, the matter shall be left to the President whose decision shall be final.

(f) (1) If at any time the President considers it necessary to have on the Managing Committee, persons whose expertise or interest in the activities of the JSS MVP is likely to benefit the JSS MVP, he may nominate such persons, not exceeding six, as Associate Members of the Managing Committee.

(2) Such persons shall fulfill all the qualifications prescribed for Life Members.

(3) Such Associate Members shall hold Office for a period of three years from the date of nomination.

(4) Associate Members shall have the right to attend meetings of the Managing Committee and to render advice on subjects placed on the agenda, but shall not have the right to vote.

(g) (1) Any member other than the President of the Managing Committee shall cease to be such member in the event of his:

(i) Death, or

(ii) Resignation, or

(iii) Conviction for an offence involving moral turpitude, or



(iv) Acquiring any physical or mental infirmity preventing him from discharging his functions, or  
(v) Insolvency.

(2) If the JSS MVP by a resolution of 2/3 rds of the Managing Committee Members, at a meeting passes a resolution for removal against a member for indulging in activities prejudicial to the interests of the JSS MVP, he shall cease to be a member.

(3) Any member other than the President or a Life Member shall cease to be a member of the Managing Committee if he does not attend continuously 3 regular meetings of the Managing Committee, without leave of absence.

VIII. PROCEDURE FOR  
MEETINGS OF THE  
MANAGING  
COMMITTEE AND ITS  
POWERS &  
FUNCTIONS

(a) The Managing Committee shall ordinarily meet once in 3 months or as and when considered necessary by the President.

(b) Notice in writing or e-mail or SMS of not less than one week shall be given for a meeting of the Managing Committee provided that a shorter notice is sufficient in case the members so desire.

(c) Three members shall constitute a quorum. If at any meeting a quorum is not present, the meeting may be adjourned to such date as the President may decide.

(d) No quorum shall be necessary for an adjourned meeting.



(e) The President may at any time call for a meeting of the Managing Committee at such shorter notice as he may decide. The notice to such meeting may be either in writing or such other telecommunication facilities such as FAX, e-MAIL, SMS, etc, as is available at the appropriate time.

(f) The Hon. Secretary or any other officer of the JSS MVP specified by the President shall cause to be placed before the Managing Committee before the 31<sup>st</sup> March of every year a budget of the JSS MVP, for approval. The Managing Committee may approve such budget with such modifications as it considers necessary and such approval shall constitute the authority to receive or expend the funds of the JSS MVP for the purpose mentioned in the budget.

(g) The Managing Committee shall have the power to appoint or remove from service any employee of the JSS MVP and the institutions managed by it.

(h) The Committee may delegate such Administrative & Financial powers as it considers necessary to any employee of the JSS MVP or of any Institution managed by it.

(i) The Managing Committee shall have the powers to frame, amend, delete, add and substitute such rules, and byelaws for carrying out the day to day activities of the JSS MVP and shall also have the power to pass such executive order(s) as it may deem fit, from time to time, to carry out the activities of the JSS MVP in a smooth and efficient manner.



(j) The Managing Committee shall have full powers to acquire through purchase, lease or otherwise, hold and maintain any immovable property or other assets for the benefit of the JSS MVP. The Managing Committee shall also have full powers to deal with the assets as it deems fit and do all such acts as may be necessary to achieve the objects of the JSS MVP and the decision of the Managing Committee shall be final.

(k) The Managing Committee shall have full powers to borrow money, if and when necessary, on the security of the assets of JSS MVP or otherwise by way of over-draft, short-term and long-term loans from Banks, Financial Institutions, or individuals for effectively achieving the objects of the JSS MVP.

IX. POWER & FUNCTIONS OF THE PRESIDENT

(a) The President shall preside over all meetings of the Managing Committee, and if for any reason, the President is unable to attend such a meeting he may authorize any other life member to preside in his place.

(b) The President shall oversee the working of the JSS MVP and all the Institutions managed by it.

(c) The President shall have full powers for authorizing utilization of funds of the JSS MVP and place the matter for information and ratification of the Managing Committee as early as possible.

(d) The President may, at his discretion, delegate any of his powers, to the Honorary Secretary / Executive Secretary / any Member of Managing Committee or any other officer of the JSS MVP. The order of such delegation shall be placed before the Managing Committee as soon as practicable.



(e) The President may appoint any one of the Life Members as Honorary Secretary for a period of 3 years which may be renewed once in three years.

(f) The Honorary Secretary shall hold the office at the pleasure of the President not with standing the term / tenure of such appointment.

(g) The President may appoint any suitable person as Executive Secretary for a period of 5 years at a time which is extendable for a similar term from time to time. The Executive Secretary shall be a Permanent Invitee to the meetings of the Managing Committee, in case he is not a Life Member.

The Executive Secretary shall hold the office at the pleasure of the President not with standing the term / tenure of such appoint.

(h) In case of need, the President may exercise the powers of the Managing Committee, as he considers necessary, and place the matter for information / ratification, as the case may be, before the Managing Committee as early as possible.

X. FUNCTIONS OF THE HON. SECRETARY

: a) The Hon. Secretary shall be responsible for arranging meetings of the managing Committee.

b) He shall cause the budget for the ensuing financial year to be placed before the Managing Committee not later than the 31<sup>st</sup> March of each year.

c) He shall be a Member of all Sub-Committees that may be constituted by the Managing Committee.

d) He shall discharge any other function as may be entrusted to him by the President.



X A. FUNCTIONS OF THE EXECUTIVE SECRETARY

e) He may make such proposals to the President for development of the JSS MVP as he considers necessary.

: a) The Executive Secretary shall implement the decisions of the Managing Committee / President and report there on from time to time.

b) The Executive Secretary is the Chief Executive Officer of the JSS MVP. He shall over-see the functioning and development of JSS MVP and its Institutions.

c) He shall be in charge of administration of JSS MVP and its Institutions.

d) He shall exercise such administrative and financial powers as may be delegated to him by the Managing Committee / President.

e) He shall arrange for maintaining accounts, auditing of accounts and preparing audit report and balance sheet and all statutory reports and submit the same for approval of the Managing Committee.

f) He shall sign the Audited Accounts and Balance sheets, and other statutory reports approved by the Managing Committee and submit the same to the prescribed Authority well in time. He shall also file Income Tax Returns, Annual Reports and other documents in respect of the JSS MVP to the prescribed Authorities.

XI. MANAGEMENT OF FUNDS & ASSETS

: a) Investment: The funds of the JSS MVP shall be invested in the modes specified under the provisions of Sec. 13 (1) (d) read with Sec. 11(5) of the Income Tax Act 1961.

b) The Managing Committee may authorize any officer / s to operate its funds to such extent and in such manner as may be specified.

XII. THE OFFICIAL YEAR : The official year of the Association shall be from the 1<sup>st</sup> of April to the 31<sup>st</sup> March of the succeeding year.

XIII. GENERAL

: a) Any alteration in the address of the Registered Office, or any amendments to the rules and change in the Memorandum of Association shall be filed with the Registrar within 30 days as per Section 9 & 10 of the Karnataka Societies Registration Act of 1960.

b) Change in the Management Committee Members, Appointments and Dismissal of the office bearers of the JSS MVP shall be brought to the notice of the Registrar, by the Hon. Secretary / Executive Secretary normally during the month of January.

c) The JSS MVP agrees to pay fees to the Registrar under Section 10(2) and Section 13 and such fees will be paid by the Hon. Secretary as per rules.

d) The Managing Committee may appoint a Chartered Accountant or an Accountant for Audit of the Accounts of the JSS MVP and authorize the payment of audit fees for the preparation of balance sheet and other accounts.

e) The audited accounts and balance sheet shall be placed before the Committee by the Hon. Secretary / Executive Secretary for approval within 3 months of the following year or at the latest on or before 30<sup>th</sup> July of each year.

f) The Committee will approve such audited report and such approved copies of the report shall be sent to the Registrar and others concerned.



XIV. AMENDMENT

: No amendments to the Memorandum of Association and Regulations shall be made which may prove to be repugnant to the provisions of Sections 2 (15), 11 to 13 and 80G of the Income Tax Act 1961. However no amendment shall be carried out without the prior approval of the Commissioner of Income Tax.

XV. WORKING HOURS

: a) The Working hours of the Registered Office of the JSS MVP will be 10.30 A.M. to 5.30 P.M with an interval of one hour. Sunday will be a Holiday in addition to other General Holidays as declared by the State Government.

b) Other offices and institutions managed by the JSS MVP shall work according to the nature of business and holidays that may suit them.

XVI. AMALGAMATIONS

: In case any other Society or Association or Trust proposes / opts for amalgamation with the JSS MVP or Vice-versa, the procedure laid down in Section 21 of the Act shall be followed.

XVII. DISSOLUTIONS

: In the event of dissolution or winding up of the JSS MVP the assets remaining as on the date of the dissolution or winding up shall under no circumstances be distributed among the members of the Managing Committee, but the same shall be transferred to another Charitable Trust, Society, Association or Institution whose objects are substantially similar to those of the JSS MVP and which enjoys recognition under Section 80G or similar provisions of the Income Tax Act 1961.

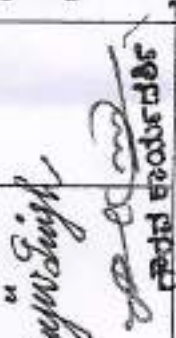

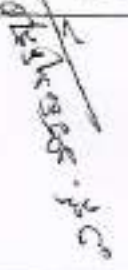
